

FOOTBALL VICTORIA ASSOCIATE AND VOTING MEMBER CLUB CRITERIA



In November 2023, Football Victoria (FV) adopted a new Constitution whereby Clubs can annually apply to be Members of FV. Clubs that complete the **Annual Club Membership Process** and meet the minimum *Associate Member Club Criteria* will be sanctioned to compete in FV Competitions. Clubs that meet the *Voting Member Club Criteria* will also be afforded the right to vote under FV's new One-Club-One-Vote Governance model and contribute to shaping the future of our sport in Victoria.

FV has long acknowledged the importance of well-governed Clubs – providing stable and welcoming environments to foster positive football experiences. The **Annual Club Membership Process** will ensure Clubs meet minimum regulatory standards and strive for equity outcomes in our game.

This document outlines the criteria that Clubs must meet to become an Associate Member Club and Voting Member Club. The Voting Member Club Criteria will be increased across the next three years, aiming to ensure clubs have a strong foundation of governance, growth and equity.

ASSOCIATE MEMBER CLUB CRITERIA

Incorporation	1. The Club must be an incorporated association under the Associations Incorporation Reform Act 2012 or be a company limited by guarantee under the Corporations Act 2001
Organises Football Teams	2. The Club organises teams to participate in competitions sanctioned by Football Victoria or Football Australia
Membership	3. The Club ensures all participants of its teams are entitled to membership of the Club and therefore may vote (or their parent or guardian may vote) in an election for any of the Club's officeholders. The Club's constitution must ensure its team participants are recognised as voting members of the Club.
Regulation Compliance	4. The Club must remain compliant with Football Australia and Football Victoria Rules, Regulations and Policies and all relevant government regulatory standards (e.g. Victoria's Child Safe Standards, ATO Requirements etc)
Financial	5. The Club is solvent and is able to pay its debts
Applies for Membership	6. The Club completes the Club Membership Process annually by the 31 December

* *Regional Clubs are only required to achieve one (1) team in each of the Team Composition Categories in 2024 and 2025 and two (2) teams in 2026*

** *Exception to Criteria 6 will be provided to dedicated Women & Girls Only Clubs*

*** *Exemption will be granted to current University Clubs from Criterion 7. The junior team entry/ies can be a team already counted in Criteria 5 or 6.*

† *Regional Clubs may seek exemption for Criterion 8 if FV is satisfied that Diversity and Inclusion programs are not available and easily accessible in their area*

The above can be achieved by a Club-to-Club Affiliation Process or the Club Merger or Amalgamation Process.
