Important Information

A club's appearance in the 'Provisional Declaration of League Structures' is not confirmation of inclusion in the 'Final Declaration of Leagues'. A club's participation in NPL/VPL/State Leagues for the 2026 season is contingent upon final league design, affiliation confirmation, promotion and relegation, approval and compliance of a variety of conditions (mandatory or otherwise) contained within various participation license agreements.

No participation is guaranteed to any club in any league until the 'Final Declaration of Leagues' is issued by FV.

Preliminary geographic zones for State Leagues will be confirmed once fixturing and venue information is submitted by Clubs. This may be subject to change if league structures are altered and/or team withdrawals occur. FV will provide clubs with further details regarding this process in the coming days.

Please note that there are a number of clubs throughout the league structures and divisions as a result of Clubs who are not currently compliant. These vacancies will be assessed with the intention to fill in accordance with the Rules of Competition.
