2026 PROVISIONAL DECLARATION OF DIVISIONS



Important Information

A club's appearance in the 'Provisional Declaration of Division Structures' is not confirmation of inclusion in the 'Declaration of Final Divisions'. A club's participation in State Leagues for the 2026 season is contingent upon final league design, affiliation confirmation, promotion and relegation, approval and compliance of a variety of conditions (mandatory or otherwise) contained within various participation license agreements.

The Declaration of Final Leagues will be determined following the Team Entry Period. All State League Women's (SLW) Clubs will be required to confirm their team participation during the Team Entry Period in February 2026. Clubs seeking to enter a new SLW team may do so during this period.

No participation is guaranteed to any club in any league until the 'Declaration of Final Leagues' is issued by FV.

Preliminary geographic zones for State Leagues will be confirmed once fixturing and venue information is submitted by Clubs. This may be subject to change if league structures are altered and/or team withdrawals occur. FV will provide clubs with further details regarding this process in the coming days.
