4.4.2(c)	Accumulation of Yellow Card suspension to be served in the competition where the most recent Yellow Card was received, instead of the competition where majority of Yellow Cards were received.	Amended in line with the FV's Competition Management platform (Dribl).
4.4.2 - Note	Removal of Yellow Card Register from FV Website.	Yellow Card data recorded and displayed on FV competition management platform (Dribl). Notifications to be issued via Dribl.
